Description of the Defect: An incorrect driver frontal airbag may have been installed in certain 2019

model year Volkswagen Jetta vehicles during a service/repair visit.

Description of the Safety Risk: The incorrect driver frontal airbag that was installed in affected vehices is a

part number used for the 2019 MY Volkswagen Golf. While this airbag/part number is generally applicable for the 2019 MY Volkswagen Jetta (and it could be assumed that the airbag will work) the documentation is incorrect. Since documentation does not exist for this part number to be used in the 2019 MY Volkswagen Jetta, there is a risk that the airbag may not work correctly; there is potentially risk of increased injury in the event of crash

with airbag deployment.

Description of the Cause: The Volkswagen electronic parts catalog incorrectly listed a driver frontal

airbag replacement part number that was not intended for the 2019 MY

Volkswagen Jetta.
