Description of the Defect: Whelen Engineering Co Inc (Whelen) is recalling various models of accessory

brake lights for use with emergency vehicles. Depending on the specific wiring of the vehicle, these brake lights may illuminate when the brake pedal has not been pressed. As such, these vehicles fail to comply with the requirements of

Federal Motor Vehicle Safety Standard (FMVSS) number 108, "Lamps,

Description of the Safety Risk: If the brake lights incorrectly illuminate, it can confuse other drivers, possibly

increasing the risk of a crash.

Description of the Cause: Whelen determined that the root cause of this condition was

tied to transient voltage on the input line creating a false and steady activation of the brake light. The condition is dependent on the specific wiring of the vehicle and other installed equipment. The product functions normally if it is not exposed to these specific conditions, but the condition can occur in all products subject to this recall. If the brake lights incorrectly illuminate, it can confuse other drivers, possibly increasing the risk of a crash.
