I am hoping you can clarify a discrepancy we noticed in Saleen's petition for an exemption from the air bag requirements of FMVSS No. 208. On page 6, the petition states that the development time for a compliant air bag system would be 15 months, but on page 8, the petition states that the development time would be approximately 18 months. Can you let us know which of these is the correct time estimate?
