Description of the Defect : During manufacturing an incorrect gauge wire, was installed unprotected in certain vehicles

Description of the Safety Risk : With an incorrect gauged wire and unprotected circuit, the wire may melt increasing the risk of a fire, injury or property damage.

Description of the Cause : The manufacturing plant did not install overcurrent protection between the distribution panel and the battery disconnect, leading to the battery.

On 4/22/2019 The during a phone conversation with a consumer and Forest River Inc. warranty manager while troubleshooting an air conditioner functionality concern; the result found the under gauge wire and unprotected circuit.

On 4/22/2019 The Manufacturing plant contacted Office of Corporate Compliance (OCC) to assist. Vehicles on the premises were inspected to find this to be true. The Manufacturing plant along with production records were used to determine vehicles affected.

On 4/26/2019 Forest River's Corporate Recall Committee voted to recall.

Description of Remedy :

Description of Remedy Program : Forest River will provide a wire and circuit breaker for installation, free of charge to the dealerships and vehicle owners. A dealership will be required to conduct this remedy.
