Descriptive Information: Affected vehicles have a roof emergency escape hatch with an optional tempered

glass panel. Specialty Manufacturing decided that certain of these glass panels, called Transpec Glass Hatches, must be replaced because they may contain a defect in the edge of the glass that can result in failure of the tempered glass. Falling glass shards from the safety hatch may fall onto passengers, increasing the risk of injury. Fourteen Proterra buses may have defective Transpec Glass Hatches installed in the rooftop emergency escape hatch because Proterra received potentially defective tempered glass hatches during the period that Speciality Manufacturing believes the defect occurred. Proterra has not received any reports of failures of the glass on Catalyst

buses.

Description of the Defect: Specialty Manufacturing Inc. has determined that a Transpec AS-3 tempered

glass panel in the rooftop emergency escape hatch may contain edge defects (chips) in the glass panels that have resulted from the manufacturing process. Hot/cold stress and vibration/shock can create stress concentrations at these edge defects that may result in fracture and failure of the tempered glass if

edge damage is present.

Chronology:

Speciality Manufacturing notified Proterra of an equipment recall 19E017 for the tempered glass hatch on June 5, 2019. On the same date, Speciality Manufacturing also notified Proterra that two deliveries of glass hatches to Proterra in September and October 2018 for 10 units each were potentially affected. Proterra investigated and determined on June 12, 2019 that 6 of the 20 units were in inventory and 14 has been installed on vehicles. Proterra has not received any reports of failures of the glass on Catalyst buses.

Description of Remedy:

Description of Remedy Program: Speciality Manufacturing will supply a replacement glass lid at no cost to the customer and reimburse up to \$25 in labor costs. The replacement of the lid involves removal of one shoulder bolt, removal of the existing hatch lid. and re-installation of a new lid and bolt.

How Remedy Component Differs The potentially defective glass hatches have part numbers T287X and have from Recalled Component: a date on the label between August 1, 2018 and February 22, 2019. The replacement lids will allow for visual inspection and identification of any defects resulting from transportation of the glass or from the hatch assembly process.

Identify How/When Recall Condition Upon receiving notice of the recall on June 5, 2019 from Specialty was Corrected in Production: Manufacturing, Proterra removed the affected parts from inventory for return to the equipment manufacturer as specified in the 19E017 owner notification letter.
