The vehicle population was determined to be all 2019 MY Maserati Levante vehicles with AFLS built from the beginning of MY 2019 production through February 20, 2019, when the vehicle assembly AFLS adjustment process was updated, that did not, according to plant repair records, have the AFLS readjusted prior to plant release. Similar vehicles not included in the recall were built after February 20, 2019, were built before February 20, 2019 but did have the AFLS readjusted prior to plant release, or were built with a

Chronology:

On May 10, 2019, Maserati SpA started testing the vertical headlamp aim of approximately 40 vehicles to determine if there was a potential FMVSS 108 noncompliance with the vertical aim on vehicles equipped with the AFLS.

On June 11, 2019, test results showed that the vertical headlamp aim on some vehicles with AFLS was higher than allowed by FMVSS 108.

Between June 12, 2019 and June 26, 2019, Maserati SpA reviewed all testing procedures, parameters and equipment setup to validate the final results brought forth on June 11, 2019.

On July 3 2019, Maserati SpA determined, through its Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected vehicles.

Description of Remedy:

Description of Remedy Program: Maserati North America will conduct a Voluntary Safety Recall on all affected vehicles to manually adjust the light beam to the correct parameters.

> Maserati North America has a longstanding policy and practice of reimbursing owners who have incurred the cost of repairing a problem that subsequently becomes the subject of a field action. To ensure consistency, Maserati North America, as part of the owner letter, will request that customers send the original receipt and/or other adequate proof of payment to the company for confirmation of the expense.
