assembly fluid and supplied to certain vehicle manufacturers that incorporated

the calipers into vehicles distributed in the U.S.

the brake calipers, which could lead to seals swelling and a reduction of

clearance in the seal groove.

Description of the Safety Risk: Brake calipers that were exposed to the incorrectly labeled assembly fluid in

production may develop a leak, which could eventually result in reduced braking function; or drag, which could potentially lead to the overheating of

the brake pads, increasing the risk of of a crash.

ZF stopped production, notified potentially affected customers, and began its investigation. On August 15, 2019, ZF learned that certain customers had distributed vehicles with potentially affected calipers in the field and made the determination to notify NHTSA.
