production. This could lead to the risk of the bed falling if someone is on or

under the bunk which could result in injury.

On 9/19/2019 a dealer called in relaying a problem they noticed with the bunk bed supports. Engineering pulled the prints for this wall and noticed the backers for the bunk supports were not on the prints for the end wall construction.

Description of Remedy:

Description of Remedy Program: 2-2 1/2" wood wrapped stiles will be shipped to the dealer to be installed in place of the current stiles. The new stiles are the full length of the slide out wall and will be attached to the aluminum framing providing securement for the full length stile.

How Remedy Component Differs The new 2 1/2" wood stiles are the full length of the end wall allowing for from Recalled Component: securement into the aluminum frame. (Part # 0307615) 2 1/2" radius stile
