10/8/2019 – Investigation opened. All affected units were put on hold and non-metallic propane gas lines were changed to copper lines.

10/9/2019 – Dealers contacted concerning the 5 units affected and parts are being shipped directly to the dealers to resolve the issue before retail sale of the units.

10/11/2019 - Investigation concluded and scope completed.

Description of Remedy Program: The remedy is to remove the non-metallic propane gas line and attach it to

the provided copper propane gas line. The provided copper gas line will make the connection inside of the range burner box and the non-metallic line will be moved outside of the range burner box. Manufacturer Reimbursement Plan on file as of 10/25/2018. General reimbursement
