median barrier.

Avila continued and struck a small white SUV head-on, he said. Her vehicle flipped and smashed into the center median barrier, killing her. The SUV was then struck from

behind by another vehicle. Two people in the SUV were taken

to University Medical Center with injuries that were not considered life-threatening.

The motorist in the other vehicle

was not seriously injured. "Unfortunately for the Highway Patrol, wrong-way drivers are not new and uncommon," Buratczuk said. "Our graveyard troopers see it almost nightly. The majority of the time it involves impairment, (and) 99 percent of the time the fatal crash happens in the left travel lane."

The crash snarled traffic from Lake Mead back to the Spaghetti Bowl for several hours during the investigation. The interstate reopened just before 9 a.m.
