Description of the Defect: During the assembly a non properly trained new operator may have not

correctly engaged the bowden cable pin inside the internal door handles.

Description of the Safety Risk: Over time the internal door handle mechanism may fail and the door cannot

be unlocked from the inside, posing an entrapment risk. This failure could lead to the inability to operate the handles from inside the vehicle with a safety risk in case of emergency. The outside handles operation is guaranteed by a different component and its functionality is not affected. Therefore, it is

still possible to open the doors normally from the outside.

Description of the Cause: Operator error during the manual assembly step of the component component.

Chronology:

On January 2020 during end of line quality checks Automobili Lamborghini S.p.A. verified few cases of nonoperative internal door handles. Automobili Lamborghini S.p.A. launched an internal investigation to determine the root cause. Results from the investigation revealed a risk that additional number of vehicles produced between December 2019 and January 2020 may present over time the issue. On March 11, 2020 the matter was presented at the Product Safety Committee where a decision to conduct a safety recall was made.

Description of Remedy:

Description of Remedy Program: Automobili Lamborghini S.p.A. will notify all owners of affected vehicles

and will instruct them to arrange for an appointment with an authorized Lamborghini dealer. Dealers will replace the whole internal door handle

free of charge.
