Description of the Safety Risk : ENC is recalling certain Axess Model buses using the Agility's Compressed Natural Gas systems that include an EMER pressure relief device. The thermally activated pressure relief devices (PRDs) installed on CNG fuel systems may not vent the system when exposed to heat above 230F, potentially resulting in the system rupturing, potentially increasing the risk of injury.
