Descriptive Information : Maxon Lift Corp is recalling certain model GPTLR & GPTWR liftgates that contain License Plate Kit 298872-01 supplied w/Light 908120-01. Light Kit may or may not have been utilized during gate installation. If kit as supplied was installed the light is at an incorrect angle for proper illumination of the License Plate.

Description of the Noncompliance : Light Kit as supplied allows the License Plate Light to not illuminate the License Plate, rather it will illuminate to the rear of the vehicle parallel to the roadway

FMVSS 1 : 108 - Lamps, reflective devices, and assoc. Equipment**FMVSS 2 :** NR**Description of the Safety Risk :** Potential confusion to other drivers on the road, increasing the risk of a crash.

Description of the Cause : Light in License Plate Kit as designed & provided shines rearward, parallel to the roadway, instead of downward to properly illuminate License Plate

Chronology :

May 2020 a reported Field issue regarding the light position on one of our lift gates was reported. Reviewed by internal team to identify all Kits and or manufactured Lift Gates that may have contained the lights.

Description of Remedy :

Description of Remedy Program : Maxon will notify the Vehicle Manufacturers who may, or may not, have used the Maxon provided License Plate Kit w/Light PN 298872-01. This is NOT applicable if the Vehicle Manufacturer used their own light. Maxon will provide a replacement kit, free of charge, to the Vehicle Manufacturers or current owners when notified of a requirement and identified SN(s) of the gate(s) requiring the recall/upgrade kit.

How Remedy Component Differs from Recalled Component : Reposition the existing light to point downward 90° properly illuminating the License Plate on kits installed utilizing the supplied 908120-01 kit lamp. Know some manufactures have indicated they may not have used the Maxon supplied Light during Lift Gate installation, This recall/upgrade does not apply to those lift gates

Identify How/When Recall Condition was Corrected in Production : May 2020 A downward pointing light to properly illuminate the License Plate in Accordance with FMVSS 108 is currently being supplied on any License Plate Kits w/light shipping. Inventory updated to the latest configuration

Recall Schedule :

Description of Recall Schedule : 1) Maxon notify all Distributors/Vehicle Manufacturers of the Order/PO/

SN of gates shipped with the License Plate Kit w/Light that may have been installed by the Vehicle Manufacturer

2) Once Vehicle Manufacturers supply SN(s) using the supplied light instead of their own a Recall Kit will be sent free of charge and Maxon warranty will authorize 1/2 hour of labor, per SN, at current rates to install the kits.

3) Once Distributors/Vehicle Manufactures contact current owners of gates no longer in their possession, and owners or Vehicle Manufacturers provide Point of Contact & SN info to Maxon; Maxon will provide the same free kit and 1/2 our of warranty labor at our current rates to the current owner once the SN and point of contact is identified
