Description of the Defect: A small number of vehicles may have an adhesive bond between the sunroof

and the vehicle body which does not meet the specification.

Description of the Safety Risk: Although we have not seen any customer cars affected, the integrity of the

bonding of the glass panel to the body may not be ensured. It is possible that the sunroof glass could become completely detached from the vehicle body. Should this occur, there would be a risk of a crash to following traffic or injury

to other road users.

Description of the Cause: During a recent routine internal process review, it was identified that a small

number of vehicles may have an adhesive bond between the sunroof and the vehicle body which does not meet the specification. This has occurred because

an incorrect rework procedure was used during vehicle production.

Identification of Any Warning It is likely that customers will experience excessive wind noise or water ingress

that can Occur: in the first instance before a complete failure occurs.
