On September 18, 2020 Winnebago Quality Control contacted the product safety department to review an identified defect with the Bracket-D Ring. An investigation began immediately to understand the scope of this defect. Winnebago Quality issued Internal Hold Notice 891 to stop all Era 170X units from shipment and have the bracket replaced. On October 22, 2020 the Winnebago Safety Committee met to review the investigation findings and decided to issue a voluntary recall. On October 27, 2020 the 573 Report was submitted to NHTSA.
