Description of the Defect: As reported by First Light Safety Products in Equipment Recall 20E-083, The

perimeter weather seal of the sign unit may become compromised allowing contaminant entry into the unit. This may result in reduced performance of the sign unit. In certain cases, an electrical short may occur which would render

the unit inoperable.

Description of the Safety Risk: As reported by First Light Safety Products in Equipment Recall 20E-083, If the

illuminated school bus sign would fail to illuminate, there would be a reduction in oncoming motorist visibility, increasing the risk of a crash. No accidents, injuries, or deaths have been reported to date as a result of this

defect.

Description of the Cause: As reported by First Light Safety Products in Equipment Recall 20E-083, the

black textured back plate of the perimeter of the weather seal may become

compromised allowing contaminant entry into the unit.

- 11/02/2020 Navistar Engineering works with FLSP to define the vehicles built with their signs.
- 11/05/2020 FLSP and Navistar meet to understand the issue and determine next steps.
- 11/11/2020 Navistar quarantines suspect population at its Tulsa Bus Plant.
- 11/30/2020 Navistar receives communication from FLSP for NHTSA recall 20E-083.
- 12/02/2020 Navistar met with FLSP to determine the basis for their decision to file a defect report and to understand their concerns relating to motor vehicle safety. Navistar then determined the suspect population.
- 12/10/2020 Navistar declares a Safety Recall.

Description of Remedy:

- Description of Remedy Program: The remedy will involve replacing the LED illuminated school bus signs.
 - FSLP will administer the campaign, notify customers, supply remedy, and provide quarterly completion reports as outlined in FSLP's defect report (NHTSA campaign number: 20E-083).
 - Because FSLP is administering the campaign, any plan for pre-remedy reimbursement will be handled by FSLP.

How Remedy Component Differs As submitted by FSLP in NHTSA Recall 20E-083, the recalled LED from Recalled Component: illuminated school bus sign was manufactured with black textured back plate of the perimeter weather seal and the remedy LED illuminated school bus sign is manufactured with a back plate with a polycarbonate perimeter weather seal.
