extension tube in the area between the extension tube and the brake caliper, and in the area between the extension tube and the brake chamber. The condition exists on the front axle only and only in vehicles with yoke type

suspension.

Description of the Safety Risk: Missing sealant could allow water intrusion into the caliper causing corrosion

and freezing of the disc brake's caliper mechanism, which could reduce the effectiveness of the trailer's front axle braking function. Although the trailers at issue all are equipped with braking systems on at least one other axle, the

diminishment of the front axle braking function eliminates braking

redundancy and could increase the risk of an accident

Description of the Cause: When Trail King manufactured the trailers, a specific sealing process was not

carried out during the assembly of the axles.

Chronology:

In November 2020, Trail King received a report from a customer regarding the performance of the front axle on a TKAHG trailer. The trailer was inspected at the dealer and found to have been missing sealant between the disc brake extension tubes and the calipers and brake chambers on the front axle and repaired. Trail King received additional similar reports thereafter and in January 2021, launched a technical investigation to understand the recurrences. The investigation found that due to a changeover in personnel in its axle assembly department that occurred at some point after May 2019, Trail King has omitted to properly seal the disc brake extension tubes during installation in production. On February 10, 2021, Trail King decided to conduct a safety recall.

Description of Remedy:

Description of Remedy Program: Trail King will inspect and seal the disc brake extension tube on the front axle of all affected trailers free of charge.

How Remedy Component Differs The remedy will result in adding sealant to the disc brake extension tube
