Descriptive Information: This report supersedes 19V-564 that was submitted on July 31, 2019.

Since Report 19V-564, certain Hino Medium Duty Trucks exhibited mirror glass adhesion issues outside of the original supplier production and vehicle production

scope determined on July 31, 2019.

Original Supplier production scope; February 13, 2019-February 27, 2019 Original vehicle production scope; February 13, 2019-March 19, 2019

1. Due to mirror glass adhesion issues occurring prior to February 12, 2019, the January 23, 2019 maintenance inspection, and investigation of collected parts, Hino will broaden the supplier scope, revising the start date to January 23, 2019.

Revised supplier scope: January 23, 2019-February 27, 2019

2. Mirror glass adhesion issues were exhibited on certain vehicles produced after March 20, 2019. Following an investigation of vehicle production, sort of defective parts, and Hino WV assembly plant relocation, Hino determined that certain medium duty trucks built outside of the original scope were found to contain mirrors built in February 2019. Hino will broaden the production scope, revising the scope to January 29, 2019-June 15, 2019.

Revised WV production scope: January 29, 2019-June 15, 2019

How the recalled products differ from products that were not included in the recall: The subject parts issue presents similar issues as reported in 19V-564. The difference in recalls relates to the scope of the recalled products as a result of additional investigation and efforts to determine the root cause. Following further investigation, Hino confirmed that the subject issue only occurs in parts manufactured between January 23, 2019, and February 27, 2019 for 2020 Hino Medium Duty trucks. 2020 Hino Medium Duty trucks that were built with parts manufactured either before or after the suspect range are not included in the recall.

#### **Description of Defect:**

Description of the Defect: Mirror glass may separate from the mirror carrier plate on mirror assemblies

for 2020 Hino Medium Duty Trucks Models: NE8J, NJ8J, NV8J, NH1A, NV1A,

TH1A.

Description of the Safety Risk: Mirror glass that separates from the mirror carrier plate may impair the

driver's visibility. Complete detachment may create road debris that could strike another vehicle or pedestrian. These may create a risk of accident or

injury.

Description of the Cause: Investigation of supplier processes determined the carrier plate did not receive

proper plasma treatment prior to glass installation due to reduced flame temperature. Investigation of supplier processes confirmed that a leak in the oxygen flow system that reduced the flame temperature during this process. As a result, for certain 2020 Hino Medium Duty trucks, mirror glass on some units

may not have full adhesion strength to the mirror carrier plate.

How Remedy Component Differs The remedy components have proper adhesive force between the mirror from Recalled Component: glass and mirror glass carrier plate. The plasma treatment process has been improved and can now detect if there is an oxygen leak or a low temperature concern. Parts built after the suspect range utilize the improved process.
