Description of Remedy Program: To address this situation, Aprilia USA will conduct a recall of models

within the affected VIN range. Aprilia USA, through the qualified Aprilia dealer network, will replace the engine in your vehicle with a new engine. This repair campaign will eliminate any potential safety risk. The work required by this recall may be completed by your qualified Aprilia dealer at no charge to you for the required parts and labor. The

work time for the repair is approximately 346 minutes.

How Remedy Component Differs The stamping code is shown on the connecting rod.

from Recalled Component: The code on the connecting rods with the defect was only "DA".

Identify How/When Recall Condition A barcode system has been introduced by sub-supplier Citt which avoids

was Corrected in Production: manual loading of heat treatment settings.

Furthermore, while before the connecting rods breakage, the heat treatment program was inserted based on the type of material and hardness of the connecting rods (therefore potentially common to several connecting rod codes of different Customers), a unique heat treatment is now defined by connecting rod code (PN 1A011945) in order to avoid

performing the incorrect process.

Supplier SPT srl has increased the checks on the Aprilia connecting rods, checking 20 pieces (hardness on 5 pieces) on all the batches received from

sub-supplier.
