### **Description of Defect:**

Description of the Defect: General Motors has decided that a defect which relates to motor vehicle safety

exists in certain 2020 to 2022 model year Cadillac CT4 and CT5 vehicles. In rare cases, the roof rail side airbags in these vehicles may not have been installed correctly during vehicle assembly. An incorrectly installed airbag may not deploy properly in a crash. This condition can exist on either the left side

or right side of the vehicle.

Description of the Safety Risk: If the roof rail side airbag does not deploy properly, there is increased risk of

injury in a crash.

Description of the Cause: The roof rail side airbag may have been assembled into the vehicle with a twist

between two of the RRAB attachment points.

#### **Chronology:**

On June 22, 2021, a GM investigator was notified by the National Highway Traffic Safety Administration (NHTSA) that the right-side roof rail airbag (RRAB) in a 2020 Cadillac CT5 did not deploy properly during a test for out-of-position occupants conducted by NHTSA on August 13, 2020. GM's investigator submitted the issue to GM's Speak Up For Safety program the next day and GM opened an investigation that same day. Inspection of NHTSA's test photos shows a twisted condition between attachment points of the affected RRAB. On July 12,

2021, a yard hold was initiated at GM's assembly plant. Inspection of approximately 1,300 vehicles on yard hold found five vehicles with the twisted RRAB condition. GM is not aware of any accidents or injuries associated with this condition. On July 29, 2021, GM's Safety Field Action Decision Authority (SFADA) decided to conduct a safety recall.
