Description of the Defect : During wheel alignment of these buses at our facilities, the alignment ring was installed at a wrong angle. In consequence, the alignment ring may pop out of place, and the wheels may become misaligned.

During routine inspection of a vehicle, it was observed that an alignment ring was missing. Investigation of other vehicles aligned during the same period revealed that the ring had been installed at a wrong angle. The period during which alignments presented the same default has been determined and all vehicles still at our facilities have been re-aligned. It was decided to recall the vehicles aligned during the identified period that have already been delivered.

No claim was received concerning this default. No accident, injury or death linked to this default has been reported.
