BBCV units with the Ford 7.3L engine may not have been installed on the affected buses. If this clamp is not installed, the brake line can rub on the exhaust pipe causing a leak or failure of the line. Failure of the brake line would

lead to:

1) Low brake pressure warning in vehicle cluster;

2) Eventual loss or degradation of front service brakes; and

3) Eventual loss or degradation of rear service brakes.

Description of the Safety Risk: Blue Bird evaluated the risk and determined if the clamp is not installed, the

brake line can rub on the exhaust pipe causing a leak or failure of the line. If

this was to occur, there is a potential for injury to the occupants and

Description of the Cause : Line personnel failed to install the proper brake line retaining clamp near the

engine.

Chronology:

On June 25, 2021, an issue with a failed hydraulic brake line was reported on a BBCV 7.3L unit during delivery to the dealer. That same day, an on-site inspection was completed and it was determined that several in process units were missing the brake line retaining clamp near the engine. A stop ship was issued to contain and rework all in process units, as well as, any units that were RFD but not delivered. Training for all operators and inspectors responsible for the affected components was completed on June 29, 2021. This issue was reported to the Blue Bird Critical Issue Review Group (CIRG). The CIRG team completed investigation of this issue and concluded that the prescribed corrective action was effective and noted that there were no additional field reports due to this issue. The CIRG team presented this issue to Blue Bird's Product Safety Committee on October 1, 2021 where it was approved to conduct a voluntary safety recall to correct this potential issue.

Description of Remedy:

Description of Remedy Program : To correct this condition, the hydraulic brakes lines near the engine need

to be inspected for proper installation. Any missing hardware will need to

be installed according to the Blue Bird provided recall instructions.
