Description of the Defect : There is a missing wall panel that protects the furnace, furnace wiring, furnace LPG hookup and ducting from cargo inside the mid-deck section of the vehicle.

Description of the Safety Risk : An owner may use the mid-deck pass-through cargo area to stow gear. Gear may unintentionally impact the furnace, wiring, LPG line. This condition may cause a wiring short, resulting in a fire.

Description of the Cause : Manufacturing failed to install the protective panel.

### Chronology :

On October 18, 2021, the manufacturing plant notified Forest Rivers Office of Corporate Compliance that they missed installing a protective panel in the mid-deck pass-through storage compartment. This panel protects the furnace, furnace wiring, furnace LPG hookup and ducting from cargo inside the mid-deck section of the vehicle. This condition was alerted to the manufacturing plant via a dealer complaint. The manufacturing plant began immediately installing the wall panels in production on this same day.

On October 20, 2021, Forest Rivers Office of Corporate Compliance received manufacturing data to determine the scope of vehicles affected.

On October 22, 2021, Forest Rivers Corporate Recall Committee voted to recall

## Description of Remedy :

**Description of Remedy Program :** Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy. A felt covered wall panel will need to be installed to protect the furnace.
