Grand Design was notified by Lippert Components, July 18, 2022. Grand Design performed due diligence in researching warranty claims and pulling the unit scope from July 20 through July 29th. The Product Safety Committee met to review findings on August 9, 2022 where it was determined a field action was necessary.

Description of Remedy:

Description of Remedy Program: Lippert Components has provided instructions for inspection and repair or

replacement as needed of awning which do not pass the inspection or have an occurrence. If repair or replacement is needed, Lippert will supply the necessary items to complete the repair or replace the faulty product. Owners that have paid to have this service performed will be reimbursed

by Grand Design for any expenses incurred relating to the defect.

How Remedy Component Differs Lippert Components is providing replacement material which is produced

from Recalled Component: after June 20, 2022 which Lippert states is certified through internal

processes.

Identify How/When Recall Condition Lippert Components identified the issue June 16th and suspended

was Corrected in Production : shipment of all inferior product. Grand Design made no changes in

production due to this being a vendor supplied component.
