Chronology:

June – July 2022: On June 27, 2022, an issue pertaining to certain 2022 Model Year Transit vehicles shipped without audio control modules (ACM) was brought to Ford's Critical Concern Review Group (CCRG) for review. CCRG review with Kansas City Assembly Plant (KCAP) personnel found that certain Transit units had been built and stored offsite prior to installation of ACMs in those units. A number of Transit vehicles were subsequently cleared and shipped from the plant prior to installation of the ACM; these vehicles were built between April 02, 2022 and May 03, 2022. A vehicle review by assembly plant personnel found that a missing ACM results in no display of the rear view camera image on the display screen, in addition to other symptoms (e.g. radio functionality, USB functionality and others.) This review was later confirmed by the relevant engineering departments and reviewed in CCRG.

As of July 13, 2022 Ford is aware of 17 warranty claims relating to a missing ACM that were received between April 13, 2022 and June 24, 2022.

As of August 03, 2022, Ford is not aware of any reports of accident or injury related to this condition. On August 05, 2022, Ford's Field Review Committee reviewed the concern and approved a field action.

Description of Remedy :

Description of Remedy Program :	Owners will be notified by mail and instructed to take their vehicle to a Ford or Lincoln dealer to have audio control module installed and programmed. There will be no charge for this service. Ford provided the general reimbursement plan for the cost of remedies paid for by vehicle owners prior to notification of a safety recall in May 2021. The ending date for reimbursement eligibility is estimated to be August 05, 2023. Ford will forward a copy of the notification letters to dealers to the agency when available.
How Remedy Component Differs from Recalled Component :	The audio control module (LK4T-18D832-KY) will be properly installed and configured.
	Kansas City Assembly Plant corrected the process on June 16, 2022, correcting the issue for Transit production.
