2022-04-11 The noncompliant driver seat belt was identified during an internal audit completed on a Prevost X3-45 Commuter. An internal Prevost investigation was launched to investigate the noncompliance.

2022-08-10 The internal Prevost investigation concluded that the issue results from a Prevost design error.

2022-09-06 Case was presented on Volvo Product Safety Working Group (PSWG) to evaluate if there is a potential safety related issue.

2022-09-15 Case was presented to Volvo Product Safety Committee (PSC). It was concluded that there was a noncompliance and that a recall is needed. Delivery Stop 22-100-DS-105 was issued to stop the delivery of new vehicles equipped with noncompliant driver seat belts. Retrofit R22062 was launched to fix the issue on vehicles in production.

2022-09-19 Noncompliance information report submitted to authorities.

No warranty claims are related to this issue. No field reports, incidents, accidents, injury, or fatality were

reported.

Description of Remedy:

Description of Remedy Program: Prevost will replace the driver seat on all affected vehicles (the

replacement driver seat comprises an integrated three-point seat belt). Letters will be sent to customers to inform them on how to proceed. Prevost will execute this correction free of charge (parts and labor) for the customers. If a customer has already inspected and corrected this noncompliance before the safety recall has been launched, this customer

will be reimbursed according to Prevost reimbursement plan

How Remedy Component Differs The remedy component is a driver seat with an integrated Type 2 seat belt assembly (3-point), while the recalled component is a driver seat with an

integrated Type 1 seat belt assembly (2-point).
