Safe Kids Worldwide and Safe Kids in Automated Vehicle Alliance Comment to the National Highway Traffic Safety Administration Federal Register Notice No. 2022-22423 Response to NHTSA Request for Comment: Proposed Data Collection Regarding Child Passenger Safety Perceptions and Practices in Ridesharing and Autonomous Vehicles

Response to Request for Comment

Safe Kids Worldwide and SKAVA strongly support the proposed data collection by the National Highway Traffic Safety Administration (NHTSA) on attitudes and behaviors of caregivers and rideshare drivers about child passenger safety practices. Such data will not only help NHTSA continually improve its occupant protection programs and policies in an expanding mode of transport but will also be useful for the broader safety community as we work to reach communities that rely on rideshares as a transport mode or as a source of their livelihoods.

As NHTSA notes in its request for comment (RFC), the use of ridesharing services by adult Americans has increased dramatically in recent years, more than doubling as a percentage of the adult population between 2015 and 2018. The safety community has come to understand anecdotally and through emerging evidence that child passenger safety behaviors on many such trips are inconsistent with best practices. Causes may include limited availability of child restraint systems (CRS) in such vehicles and occupant protections laws exempting taxi, livery, and rideshare vehicles from child restraint requirements. More complete data on caregiver and driver attitudes, as well as the challenges faced by both groups, can inform the work of both NHTSA and the broader traffic safety community to address these inconsistencies.
