On December 20, 2022, Mercedes Benz notified Jayco Inc. of active recall 22V-796 regarding Park Lock

Function. On December 21, 2022, CPAC (Corrective and Preventive Action Committee) reviewed the information and elevated this to SSC (Safety Steering Committee). On February 13, 2022, SSC voted to proceed with filing a chassis pass through recall. Jayco Inc. is not aware of any reports of accidents or injuries associated with this concern.

Description of Remedy:

Description of Remedy Program: As a precautionary measure, Mercedes-Benz AG, via its Mercedes-Benz

service partners, will update the software of various control units (ESP control unit, transmission control unit, electronic ignition switch control unit and direct select module control unit) on the affected vehicles. Pursuant to 49 C.F.R. § 577.11(e), MBUSA does plan to provide notice about pre-notice reimbursement to owners since most of the involved vehicles would have been previously subject to the condition described and customers who have already paid to have this recall condition

corrected may be eligible to receive reimbursement.
