Description of the Defect : The speedometer cable was incorrectly routed on the vehicles, resulting in an insufficient fit with the pinion gear and causing a gap in the speedometer's cover. The incorrect routing can result in the cable either breaking by the speedometer side or detaching by the brake panel side.

Description of the Safety Risk : If the speedometer cable breaks or detaches, the speedometer is rendered inoperable, increasing the risk of a crash or injury.

Description of the Cause : The speedometer cable was routed incorrectly on the vehicle, causing the cable to either break or detach.

Chronology :

February 2022

Honda received its first report of a speedometer cable detaching and launched an investigation.

March 2022

Honda received additional reports of speedometer cables detaching and received its first report of a speedometer cable breaking.

July 2022

Honda received additional reports of speedometer cables breaking and launched another investigation.

August 2022

Honda reproduced the cable detachment during testing.

December 2022

Honda reproduced the cable breakage during testing.

February 28, 2023

Honda identified the mechanism for the cable breakage and detachment issues.

March 16, 2023

Honda determined that a defect related to motor vehicle safety existed and decided to conduct a safety recall. As of March 16, 2023, Honda has received 38 warranty claims related to the issue between February 16, 2022 and March 16, 2023 with no reports of injuries or deaths related to this issue.

Description of Remedy :

Description of Remedy Program : Registered owners of all affected vehicles will be contacted by mail and asked to take their vehicle to an authorized Honda Powersports dealer. The dealer will replace the speedometer cable with appropriate cable routing.

Owners who have paid to have these repairs completed at their own expense will be eligible for reimbursement, in accord with the recall reimbursement plan on file with NHTSA.

How Remedy Component Differs from Recalled Component : While the replacement speedometer cable remains the same, the cable will be correctly routed.

Identify How/When Recall Condition was Corrected in Production : The recall condition was corrected by properly installing the cable.
