October 31, 2022 Jayco's Warranty Incident Review Committee (WIRC) reviewed the incident and elevated it to CPAC. On November 2, 2022 The Corrective Preventive Action Committee (CPAC) decided to elevate the incident to the Safety Steering Committee (SSC) once the remedy was available and the Ford recall became active. In March 2023, Ford notified Jayco that remedy parts are available. On March 23, 2023 SSC voted to proceed with a pass through chassis recall.

#### **Description of Remedy:**

Description of Remedy Program: Owners will be notified by mail and instructed to take their vehicle to a Ford or Lincoln dealer to inspect bolt torque for both rear stabilizer attachment brackets. If each of the bolt torques on the same bracket are greater than 25Nm, replace weld nuts with flag nuts and replace bolts. Otherwise, if either bolt torque on the same bracket is less than 25Nm, replace weld nuts with flag nuts, replace bolts, and replace bracket. There

will be no charge for this service. Ford provided the general

reimbursement plan for the cost of remedies paid for by vehicle owners

prior to notification of a safety recall in May 2021.
