 - The traffic safety field is at a crossroads, with emerging technology making a large impact on traffic safety trends

 - B. Traffic Records Data Integration
 - 1. Summary of Work Sladjana Oulad Daoud
 - Reviewed Chapter 10: Traffic Records Data Integration
 - a. This chapter discusses optional noteworthy practices for integrating data from other traffic records component systems with crash data.
 - b. The Subcommittee focused on clarifying the intent of the chapter, integration vs interfacing, and the benefits of data linkage and interfaces.
 - c. The Subcommittee also discussed providing a list of examples of data integration from across the country, and if this chapter is a suitable home for these examples.
 - d. This chapter will not be used for mapping to the MMUCC guideline, but it has other benefits for States.
 - 2. Questions for the Subcommittee
 - Sladjana Oulad Daoud: Sladjana enjoyed being on this Subcommittee and found the discussion between members useful.
 - C. IT Database Design and Administration Subcommittee
 - 1. Summary of Work Thomas Gwinn
 - Reviewed Chapter 3 System Populated Data Elements
 - Reviewed Chapters 4-8 Implementation Suggestions and Validation Rules
 - Reviewed Chapter 11: Designing User-Centered Crash Reporting Systems
 - a. This Subcommittee reviewed design and implementation suggestions for each element.
 - b. The Subcommittee was impressed by how well-written and organized the MMUCC Sixth Edition is and found the discussions about nonmotorist data elements informative.
 - 2. Questions for the Subcommittee
 - a. David Kelly: Expressed concerns with how the document names the individual fields, with a suggestion to shorten the field names.
 - b. Allison Hawley: Appreciated the Subcommittee and the collaboration and discussion from other States on how data is used. Allison looks forward to meeting Subcommittee members at the Traffic Records Forum.

V. Open Forum

- A. What is NSCA's process for reviewing suggestions for draft MMUCC Sixth Edition?
 - 1. Joanna Reed: NCSA is reviewing all 400+ suggestions from the MMUCC Committee, the public, NHTSA, Federal Liaisons, and elsewhere and determining how best to incorporate the suggestions into the MMUCC Sixth Edition.
 - 2. NCSA will finalize the MMUCC Sixth Edition, working along with the NCSA State Electronic Data Collection (SEDC) group on deadlines. NCSA hopes to have the MMUCC Sixth Edition elements and attributes list completed when the SEDC Notice of Financial Opportunity (NOFO) gets posted in August (estimated).
 - 3. The MMUCC Sixth Edition final draft will be sent to NHTSA Leadership for final review and approval in November (estimated).

- 4. NCSA's Associate Administrator, Chou-Lin Chen, is the final authority over MMUCC.
- 5. NCSA anticipates the MMUCC Sixth Edition to be published in January or February 2024.
- B. When will States know if there are required MMUCC elements for the MMUCC Sixth Edition, such as the serious injury mandate in the MMUCC Fourth Edition?
 - 1. Joanna Reed: MMUCC remains a voluntary guideline. The previous serious injury mandate still stands.
 - 2. The National Definition for Serious Injuries noted by Joanna that remain: https://safety.fhwa.dot.gov/hsip/spm/docs/factsheet-mmucc-4edition.pdf
