*February 18, 2022* The Technical Service of the manufacturer PREMIORI LLC carried out a complete analysis of the sidewall marking of the available molds for the subject tires. We found one mold of this size of tires

February 19, 2022 We have corrected this noncompliance

*February 20, 2022* After investigating the reasons for this noncompliance and consulting with the technical service of the company, it was concluded that this did not affect the safety of vehicles

*March 10, 2022* We sent the answer to the Request for each sub-item separately, indicating the relevant sources of information and attached files by e-mail Mr. Lindley

#### 6. Cause:

Untimely detection of noncompliance of the sidewall marking of the tires

#### 7. Safety Risk(s):

With regard to the marking of the subject tires PREMIORRI Solazo according to FMVSS No. 139, Section S5.5, each tire is marked with the information specified in S5.5 (a) - (i). The marking is in letters and numbers at least 0.078 inches high and placed at least 0.015 inches above the tire surface

(a) DOT symbol: KC F1 0822;

(b) tire size designation:175/65R14;

(c) maximum permissible inflation pressure: 300 kPa (44 psi);

(d) maximum tire load: 475 кg (1047 Ibs);

(e) general name of each cord material used for the tire plies (both sidewall and thread): POLYESTER, STEEL, NYLON;

(f) actual number of sidewall plies: 1 POLYESTER and actual number of tread plies: 2 STEEL + 1 NYLON;

(g) "TUBELESS": tubeless tire;

(h) "RADIAL": the subject tire is a radial design tire;

(i) no alpine symbol, as the subject tire is a road tread tire.

Each tire is marked with a trademark: PREMIORRI Solazo manufacturer name.

The company PREMIORI LLC assumes that in this case there is a single risk associated with noncompliance, and it concerns the misleading of the consumer regarding the DOT marking on one side of the sidewall of the tire.

#### 8. Justification:

The Technical Service of the manufacturer PREMIORI LLC carried out a complete analysis of the sidewall marking of the available molds for the subject tires.

In total, we have 4 (four) molds for this tire size. We have found one (1) mold with DOT marking on one sidewall.

To confirm this, we can provide a photo with markings of the subject tire 175/65R14 PREMIORRI Solazo on both sidewall.

#### 9. Actions:

We have taken corrective actions regarding this noncompliance.

At this moment the marking of both sidewall meets the requirements, that is, DOT symbol as a full tire identification number is on one sidewall, and DOT symbol as a partial identification number is on the other sidewall.

To confirm this, we can provide a photo with markings of the subject tire 175/65R14 PREMIORRI Solazo on both sidewall.

#### 10. Conclusion:

Therefore, the company PREMIORI LLC assumes that in this case there is a single risk associated with noncompliance, and it concerns the misleading of the consumer regarding the DOT marking on both sides of the sidewall of the tire. However, this noncompliance does not relate to motor vehicle safety.
