On October 23, 2023, Forest Rivers Office of Corporate Compliance ("OCC") was made aware of a concern by the supplier, Trans/Air. Trans/Air has indicated that in certain applications that their compressors mounted to the OEM chassis may come into contact with and become damaged, and cause damage to/or impede the operation of the vehicles' stabilizer bar.

On October 26, 2023, Forest Rivers Office of Corporate Compliance ("OCC") alerted Forest Rivers Corporate Recall Committee of this pass through equipment recall.

Description of Remedy:

Description of Remedy Program: Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy. The vehicle will be inspected for the sway bar, if no sway bar is present there is no action needed. If the sway bar is present the new updated compressor mount will be installed.
