Following a long hiatus in the installation of transversal wheelchair track anchorages, it was inquired on April 24, 2023 to validate the installation method and hardware for these tracks before installing new transversal

Tests were conducted and, after further analysis, it was concluded that the hardware used in the past may not be sufficient to comply with Motor Vehicle Safety Regulations, Standard #222, School Bus Passenger Seating and Crash Protection.

On November 16, 2023, it was decided to recall the vehicles equipped with transversal wheelchair track anchorages.

Micro Bird has not received any report of incident or claim regarding this noncompliance.

Description of Remedy:

Description of Remedy Program: Micro Bird Corporation will provide field modification instructions and

material to mitigate this recall at no charge. It will be the responsibility of the bus owners to have their vehicle(s) corrected by a Micro Bird dealer.

Owners who have incurred costs to obtain a remedy for the defect

addressed by this recall campaign within a reasonable time in advance of notification, may submit their claims to Ecotuned Technologies.
