On June 26, 2024, during a routine Corporate Standards Audit, it was discovered that manufacturing was not installing a secondary means of egress. The same day, the Corporate Standards Manager notified Forest River's Office of Corporate Compliance ("OCC"). OCC opened a research item.

On June 28, 2024, Forest River's Corporate Recall Committee voted to recall.

Description of Remedy Program :	Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy to install an egress window.

Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles (as needed) once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
