Delco learned of an injury to a horse due to the center gate latch not engaging on 5/06/2024 when the end user contacted Delco Warranty.

Delco requested more information from the Dealer on May 14, 2024.

By 6/13/2024 Delco received additional information as to the extent of the injury to the horse.

As of 6/20/2024 Delco was able to start inspection on the trailer involved to make determinations on safety of the current design.

And on 6/26/2024 Delco determined that in order to increase the safety of the trailer a secondary latch would be implemented.

## **Description of Remedy:**

Description of Remedy Program: Delco plans on notifying consumers and dealers of this safety recall. Delco

plans on sending an attachable secondary latch to our dealers to install on the trailers affected. Trailers that have already had a secondary latch installed by end users will be reimbursed for the cost of the latch and labor

for installation.

How Remedy Component Differs An additional latch will be added to the gate mechanism. This is designed

from Recalled Component: to prevent the gate swinging open and injuring any animal inside

Identify How/When Recall Condition Once we were initially made aware of the injury to the horse we paused was Corrected in Production: production on the H-Series trailers. A new gate was designed with a secondary latch system and will be used on all future H-Series trailers.
