Chronology:

March 14, 2024, Autocar personnel identified a single unit missing the retaining rings from the cab tilt pins. March 19-21, all in-house units were guarantined and inspected, and a clean point established for production. March 21-June 21, 2024, Autocar personnel inspected multiple units in the field and deployed additional inspection and installation practices. June 27, 2024, all relevant information was presented to Autocar's management team and out of an abundance of caution, Autocar decided to perform a voluntary Safety Recall. Note: We have no known cases, complaints, or claims, all were identified during manufacturing and inspection processes.

Description of Remedy:

Description of Remedy Program: Autocar will voluntarily initiate an owner notification and recall of all affected vehicles. Autocar will distribute to owners of affected vehicles an Owner Notification Letter, which will describe the defect and provide instructions for scheduling the inspection/repair of the vehicle at no cost to the vehicle's owner. The owner letter will instruct vehicle owners who have paid to have this condition remedied prior to this campaign to seek reimbursement pursuant to Autocar's General Reimbursement Plan, on file with the agency pursuant to 49 C.F.R. 573.6(c) (8) (i) and 49 C.F.R 573.13.

How Remedy Component Differs The cab tilt pins will be inspected and if found to be defective or missing, from Recalled Component: the retaining ring(s) will be replaced at no charge to the owner.

Identify How/When Recall Condition . March 19-21, 2024, all in-house units were quarantined and inspected, was Corrected in Production: and a clean point established for production. May 14, 2024, internal training completed, and additional inspection processes were put in place.
