Description of the Defect : The exterior griddle may be stowed while still connected to LP Gas.

FMVSS 1 : NR

Description of the Safety Risk : The exterior griddle may be stowed while in use, increasing the fire risk.

Description of the Cause : When adding an exterior spray port to the vehicle model, the LPG line was located in a way that allows the griddle/grill to be stowed while in use.

On August 6, 2024, Forest River's Office of Corporate Compliance ("OCC") was notified by the manufacturing plant that they had received a complaint from a customer that the LPG hose to connect to the quick disconnect to the griddle while the griddle was in the mounted position, may allow the griddle to be stowed into the vehicle.

On August 8, 2024, OCC visited the manufacturing plant to look at the installation.

On August 13, 2024, OCC continued research into the concern.

On August 16, 2024, Forest Rivers Corporate Safety Committee voted to recall.

Description of Remedy :

Description of Remedy Program : Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer or service center will need to perform the remedy to relocate the hose and connection so that the griddle cannot be connected to LP and stowed in the vehicle.

The LPG hose will now be a shorter length, which will not allow the griddle to be installed inside the vehicle while in use.

Identify How/When Recall Condition was Corrected in Production : During the week of August 17, 2024, the manufacturing plant changed the length of the LPG hose.

Description of Recall Schedule : Forest River has the utmost urgency in our recalls. Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles (as needed) once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
