Chronology :

On August 12, 2024, Forest River's Office of Corporate Compliance ("OCC") was notified by the manufacturing plant of a single vehicle in which the outrigger may contact the tire.

On August 14, 2024, OCC opened a research item into the concern. OCC asked the division to get the dimension between the tire and the outrigger. Additionally, OCC asked the division to reach out to dealers with stock inventory to inspect for a possible concern.

Between August 16 through August 19, the manufacturing plant began receiving data points back from multiple dealers.

On August 22, 2024, Forest Rivers Corporate Committee voted to recall.

Description of Remedy :

Description of Remedy Program :	Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer or service center will need to perform the remedy to remove the outriggers, replace with new and relocate them to a location that will not interfere with the tire(s).

Identify How/When Recall Condition was Corrected in Production :	In February 2024, the manufacturing plant added length to the floorplan. The outriggers were moved out of the tire jounce area.

Description of Recall Schedule :	Forest River has the utmost urgency in our recalls. Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles (as needed) once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
