On August 13, 2024, Forest River's Office of Corporate Compliance ("OCC") was notified by the manufacturing plant of a single vehicle in which the tire may contact a chassis component.

On August 14, 2024, OCC opened a research item into the concern. OCC asked the division to get the dimension between the tire and the chassis components. Additionally, OCC asked the division to reach out to dealers with stock inventory to inspect for a possible concern.

Between August 16 through August 20, the manufacturing plant began receiving data points back from multiple dealers.

On August 22, 2024, Forest Rivers Corporate Committee voted to recall.

How Remedy Component Differs Affected Component – Axle Hangers

from Recalled Component : The new axle hangers and riser kit will now allow the desired distance between the tires and the chassis components under a full jounce of the vehicle.

Identify How/When Recall Condition was Corrected in Production : The week of August 19, 2024, the manufacturing plant had a riser installed, lifting the vehicle 3 inches, allowing clearance of the tire and chassis components.

Recall Schedule :

Description of Recall Schedule : Forest River has the utmost urgency in our recalls. Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles (as needed) once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
