Description of the Noncompliance : The 2020 Titan SRW School Bus does not comply with the '10.4 Emergency Exit & Labeling

Instructions" requirements. The emergency exit instructions on the driver side failed to meet the height requirement of 1 cm, measuring in at 0.35 cm

S5.5.3(b): Emergency Exit Identification: Concise operating instructions describing the motions

necessary to unlatch and open the emergency exit shall be located within 15 centimeters of the

release mechanism on the inside surface of the bus. These instructions shall be in letters at

least 1 centimeter high and of a color that contrasts with its background.

FMVSS 1 : 217 - Bus emergency exits and window retention and release

Description of the Safety Risk : Inability to see the instructions for the the emergency exit operation when not placed at the proper height could prevent proper emergency exit procedures from occurring

Description of the Cause : S5.5.3(b): Emergency Exit Identification: Concise operating instructions describing the motions necessary to unlatch and open the emergency exit shall be located within 15 centimeters of the release mechanism on the inside surface of the bus. Chronology :

On a lab test performed on 5/20/24 it was determined and reported by NHTSA that the subject Endera/Titan SRW School Bus model year 2020 did not comply with the FMVSS 217 regulation regarding proper bus emergency exit window labeling instructions. Reporting took place from NHTSA to Endera Motors on 6/11/24. Investigation of the reported failure was conducted by Endera Motors internally and confirmed via email on 7/19/24 that this issue would be recalled in order to properly be addressed. On 8/22/24 the recall was submitted via the NHTSA portal.

Description of Remedy :

Description of Remedy Program : The defective sticker will be replaced by Endera Motors and will be replaced at no cost to the owner's of the current vehicles. The vehicles that are currently under warranty will not eligible for reimbursement since the cost will be covered by the Endera warranty

How Remedy Component Differs from Recalled Component : The new decal will be installed at the proper height which is mandated in the FMVSS regulations. S5.5.3(b): Emergency Exit Identification: Concise operating instructions describing the motions necessary to unlatch and open the emergency exit shall be located within 15 centimeters of the release mechanism on the inside surface of the bus. These instructions shall be in letters at least 1 centimeter high and of a color that contrasts with its background.
