Chronology:

In June 2024, during inspection, an unusual noise coming from the engine drive belt was reported. Cursory investigation identified that this might be linked to the installation of a second air conditioning compressor.

The issue was reported to Oliva Torras and analysis of the possible causes was initiated, both by Oliva Torras and Micro Bird.

Initially, the cause was identified as an increase of tension of the engine drive belt on the idler pulleys. But after more tests, it was determined that the tensioner provided by Oliva Torras and that replaced the tensioner installed originally by GM, was not strong enough to correctly maintain the tension in the engine drive belt, allowing the drive belt to move on the pulleys and even become loose.

After identification of the defect and its safety risk, on September 16, 2024, it was decided to recall all the vehicles delivered with the identified second air conditioning compressor.

Micro Bird has not received claims nor is aware of any incident linked to this defect.
