Noncompliance: The tire load range listed on the label is C and should be listed as E. As a result,

the labels fail to comply with the requirements of FMVSS Number 110, Tire selection and rims and motor home/recreation vehicle trailer load carrying capacity information for motor vehicles with a GVWR of 4,536 kilograms

(10,000 pounds) or less.

Chronology:

On September 17, 2024 Jayco Customer Service emailed Jayco compliance department that the Tire and Loading Information labels have the incorrect tire load range listed. The tire load range listed on the label is C and should be listed as E. An internal investigation began.

On September 18, 2024 during the investigation, the Jayco Inc. Chassis administration confirmed that there was a Data entry error, which resulted in the tire load range C being printed on the tire and loading information labels instead of the correct tire load range E.

On September 23, 2024, the Warranty Incident Review Committee (WIRC) discussed the incident and determined it should be elevated to CPAC.

On October 2, 2024, the Corrective and Preventive Action Committee (CPAC) met to discuss this incident and elevated it to the Safety Steering Committee.

On October 8, 2024, the Safety Steering Committee voted in favor of proceeding with a noncompliance recall for failing to comply with the requirements of FMVSS Number 110, Tire selection and rims and motor home/ recreation vehicle trailer load carrying capacity information for motor vehicles with a GVWR of 4,536 kilograms (10,000 pounds) or less.

Description of Remedy:

Description of Remedy Program: Jayco Inc. Dealers or the retail owners will adhere the Tire and loading information label showing the correct tire load range E listed. Repairs made prior to the recall will be reimbursed in accordance with our Recall Reimbursement Plan on file with NHTSA. There are no warranty claims or complaints associated with this recall. Jayco Inc. will be reporting the quarterly completion rates to NHTSA.

Tire and loading information label will list the correct tire load range E
