Description of the Defect : The inverter may be connected to constant "hot" on the second battery, whereas it should be on a breaker side on the second battery.

Chronology :

On October 22, 2024, the manufacturing plant discovered that they may have been inconsistently hooking the inverter directly to a second battery, without over-current protection, in certain cases.

On October 25, 2024, the manufacturing plant notified Forest River's Office of Corporate Compliance ("OCC") of the concern. OCC opened a research item.

On October 28, 2024, the manufacturing plant and OCC identified there may be vehicles in commerce inconsistently wired.

On November 1, 2024, Forest River's Corporate Recall Committee voted to recall. All vehicles are located at Dealers, there will be a stop sale notification issued today.

Description of Remedy :

Description of Remedy Program :	Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy to wire the inverter to the breaker side on the second battery. What is the Forest River Customer Service Phone Number? (574) 264-6664 If you have already paid for a repair that is within the scope of this defect under recall, you still need to have this recall inspected and/or performed to ensure the correct parts and procedures were utilized. Additionally, you may be eligible for a refund of previously paid repairs. Refunds will only be provided for within the scope of this defect under recall. How Remedy Component Differs from Recalled Component :	12V Wiring The inverter will now be wired to the breaker on the second battery.
Identify How/When Recall Condition was Corrected in Production :	The week of October 25, 2024, and October 28, 2024, the manufacturing plant corrected the vehicles in the yard and in production by moving the inverter wire to the breaker side of the second battery.

Recall Schedule :

Description of Recall Schedule :	Forest River has the utmost urgency in our recalls. Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles (as needed) once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
