Chronology :

On July 9, 2024, a case was reported from a non-US market of a loose oil filter while riding at high speed, resulting in a complete loss of engine oil, which occurred directly after a service visit with an oil change. On July 22nd, the same dealer reported a second case with similar characteristics, despite having paid special care to the torquing of the oil filter at the time of the service oil change. An engineering investigation was initiated, the parts were held for analysis, and the supplier was contacted.

Between August and September, 4 additional field incidents occurred (which included 1 in the US market). A review of the field data indicated that only oil filters from the MAHLE production plant in Brazil were involved and included only models with four-cylinder engines capable of operating at high engine rev levels (> 12,500 rpm).

A review found that when oil filter production was transferred by the supplier from a plant in Austria to a plant in Brazil, that minor design changes to the upper filter section (screw plate and sealing) had occurred. Extensive test bench analysis determined that the Brazilian filter was susceptible to vibrations occurring in four-cylinder engines at high rev levels. This effect was non- existent on filters from the previous production plant in Austria.

From October through November 4th, 7 additional field incidents occurred (which included 1 in the US market).

On November 7, 2024, BMW decided to conduct a voluntary safety recall.

BMW has received one report of an accident in a non-US market related to this issue.

Description of Remedy :

Description of Remedy Program :	The oil filter will be inspected and, if necessary, replaced.

Although owner notification is not required - because the last known purchasers to BMW of the dealer service part oil filters are the motorcycle dealers – nevertheless, BMW owners who have had their motorcycle serviced in which the oil filter was replaced will be notified by First Class mail and instructed to contact an authorized BMW motorcycle dealer to have the remedy performed for free. If this condition were to occur to a potentially affected dealer service part oil filter prior to the recall, the remedy would be covered by the BMW New Parts and Accessories Limited Warranty program. Therefore, reimbursement for a pre-notification remedy re Part 573.13 and Part 577.11 is not necessary.
