

Description of the Defect :	A rod connecting the brake pedal to the hydraulic brake unit may not have been assembled correctly at the supplier. The final torque might not be according to manufacturing specification due to deviations in the equipment.

Description of the Safety Risk :	As a result, a reduction in brake support functions can occur increasing the risk of a crash.
Description of the Cause :	Misalignment in the supplier's assembly station where the parts were assembled between May 15th 2019 to September 27th 2019.
	If the connection is loose there might be noise issues and an unstable pedal. Bad ergonomics due to a larger distance between the brake pedal and the accelerator pedal will occur if the pushrod starts to become loose.
