- On November 4, 2024, the manufacturing plant discovered they were inconsistently wiring the solar panel to the solar controller. The manufacturing plant contacted Forest River's Office of Corporate Compliance ("OCC"). OCC opened a research item.
- On November 8, 2024, Forest Rivers Corporate Committee voted to recall.

Description of Remedy Program :	Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy to properly wire the solar panel to the solar controller.

Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles (as needed) once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
