Description of the Safety Risk: If the Mercedes Benz spare tire is attached with the Method wheel bolts, the

appropriate torque cannot be achieved. An inaccurately torqued wheel bolt increases the risk of the tire coming off in transit, which can increase the risk

of an accident.

Description of the Cause: Mercedes Benz wheels are replaced with Method Wheels, which require a

different wheel bolt. Production drawings did not call out to include a set of the

Mercedes Benz wheel bolts for use with the spare tire.

#### **Chronology:**

In mid-August Product Safety was notified of a concern regarding missing wheel bolts for the spare tire. An investigation was subsequently opened. During the investigation it was found if the Mercedes Benz spare tire is mounted with the Method wheel bolts there is potential for the wheel to come off in motion and a wrench to remove the Method wheel bolts was not included.

Production corrected the concern and began including the spare tire wheel bolts and a hex wrench. The Product Safety Committee met November 18, 2024 and decided the issue presented a safety risk and a recall was initiated.

Winnebago is not aware of any claims, injuries, or property damage as a result of this condition.
