2024-10-02 Issue identified in production during an internal Volvo audit.

2024-10-08 Internal Volvo investigation was opened to identify the root cause and to determine if the issue is safety related or a non-compliance. Volvo considered the information included in the internal Volvo audit report when evaluating the existence of a potential non-compliance.

2024-11-12 Case was presented on Volvo Product Safety Evaluation Committee (PSEC) to evaluate if there is a potential non-compliance issue. Decision made to raise the potential non-compliance issue to Volvo Product Safety Committee (PSC) for review and determination.

2024-11-21 Case was presented to Volvo Product Safety Committee (PSC). It was concluded that there was a non-compliance issue and that a recall is needed.

2024-11-21 Delivery Stop was issued at the Mexico manufacturing facility to stop the delivery of vehicles until corrective actions are implemented.

2024-11-21 Internal campaign was launched at Volvo Mexico to solve the issue on all vehicles in production before being delivered.

2024-11-21 Delivery Stop was issued by Prevost to stop the delivery of vehicles until they are remedied.

No warranty claims related to this issue. No field reports, incidents, accidents, injury, or fatality were reported.

Description of Remedy :

Description of Remedy Program :	Prevost will replace the non-compliant emergency exit labels with redesigned labels that have been validated for compliance. Letters will be sent to customers to instruct them how to proceed. Prevost will execute this correction free of charge (parts and labor) for the customers. In case a customer has already inspected and corrected this defect before the safety recall has been launched, this customer will be reimbursed according to Prevost reimbursement plan.
v 1	After the remedy, the redesigned emergency exit window labels will be securely affixed to the vehicle.
^c	The recall condition was corrected in production on November 21, 2024, when an internal campaign was launched. All vehicles are remedied prior to delivery.
