On December 10, 2024, during a routine Forest River Pre Delivery Inspection ("PDI") it was discovered that the LP Tray did not have the appropriate amount of fasteners attaching it to the chassis.

On December 11, 2024, OCC was notified, and a research item was opened. A warranty report was not run for this issue as it was found during an inspection at the manufacturing plant.

On December 13, 2024, Forest Rivers Corporate Recall Committee voted to recall.

Description of Remedy :

Description of Remedy Program : Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy to install the correct amount of fasteners. To reduce the safety risk, Forest River recommends the LP tank(s) be removed before taking to a dealer for repair.
